Biography

Jake's scholarly publications include several books and many book chapters and refereed articles on peace and Peace Journalism. Jake has served as Guest Editor of themed Special Editions of scholarly journals: *Global Change, Peace and Security* (2008); *Ethical Space: The International Journal of Communication Ethics* (2013) and *Media, War and Conflict* (in production for publication in 2014). Each is based on a proposal he submitted, and featured articles by contributors to a conference he organised.

Jake's teaching interests range broadly over topics in Peace and Conflict Studies and cognate disciplines. Units of study he has coordinated, since taking up his post at the University of Sydney, include:

- Key Issues in Peace and Conflict Studies;
- Conflict-resolving Media;
- Information Interventions in Conflict;
- Political Economy of Conflict and Peace, and
- Human Rights, Peace and Justice.

All are in CPACS' Postgraduate Coursework programme. He has contributed to Undergraduate units including Critical Media Practice, and History and Philosophy of War and Peace. He created, and coordinates, CPACS' Distance Learning Masters program, allowing students to join from all over the world.

Before taking up an academic post, Jake enjoyed a near-20-year career in professional journalism, culminating in a role as an on-air presenter for BBC World TV, where he anchored over a thousand full half-hour news bulletins. Before that, he was Sydney Correspondent for the London *Independent* newspaper, and a Political

Correspondent for Sky News at Westminster. He was Director of the journalism think-tank, Reporting the World, www.reportingtheworld.net, launched with funding from the Department for International Development.

Jake is also the author of several policy reports and over 150 articles on peace-related topics in public media including *New Matilda*, *OpenDemocracy*, TRANSCEND Media Service, the *Sydney Morning Herald*, the *Australian* and the *Canberra Times*. He has senior production credits on four documentary films, including the multi-award winning *Soldiers of Peace*, narrated by the Hollywood actor, Michael Douglas.

In 2009, he won a Linkage grant from the Australian Research Council, to investigate prospects for devising a Global Standard for Reporting Conflict, in partnership with the International Federation of Journalists and the aid agency, Act for Peace.
