INDICATORS OF RESEARCH EXCELLENCE. Award: the NHMRC project completed in 2014/5 in the NT, led by LB was judged by NHMRC as one of the '10 Best' for 2014. This study investigated the nature and quality of maternal infant health care provided to Aboriginal women and infants in the Top End of NT and guided significant improvement **Publications:** LB has published over 50 refereed papers in the last five years [with 20 in the last 24 months] and written or edited 2 books in the last decade. She has written, with others, numerous high-level reports for industry e.g. a Framework for Universal Child and Family Health Services for the Child Health and Wellbeing Subcommittee of the Australian Health Ministers Advisory Council, 2010; and Maternal mortality, unplanned pregnancy and unsafe abortion in Timor-Leste: for the United Nations Population Fund 2009. **Grants:** She has been a chief investigator on 17 Group 1 grants leading 9 of these. She has recently completed her last NHMRC grant as lead CI and is a CI on 2 others currently being undertaken. **PHD Students:** LB has supervised over 30 doctoral students, service leaders or clinicians from midwifery, allied health or medicine. She currently supervises 2 doctoral students. She examines theses, around 2-3 annually, for a range of national and international universities
